We are happy to assist with writing official letters of invitation to those who need it for receiving a visa.

ISHR Ukraine

ISHR President meets with Ukrainian lawyers and human rights defenders in Kiev

On December 9, 2017, in Kiev, a meeting of lawyers and human rights defenders with the President of the International Society for Human Rights, Prof. Thomas Schirrmacher, and his wife, Prof. Christine Schirrmacher, took place. Participants in the meeting discussed the observation of the right to a fair trial in Ukraine.

In particular, the issues discussed included those that appeared in litigations against journalists Muravitskiy,

Vasilets and Timonin, managing officers of tax authorities (the so-called "helicopter case" or the "case of tax collectors"), and in criminal proceedings against the former president of Ukraine, Viktor Yanukovych.

According to the lawyers, violation of human rights includes the following:

- Accusation of journalists of high treason in connection with their professional activity publication
 of the materials criticizing the state authorities and particular representatives thereof;
- Abuse of power by the military prosecutor's office, in particular, prosecution of criminal cases on accusations which do not envisage participation of its representatives in the process (processes against the tax authority offices who are accused of corruption and who are not connected with the army or the military conflict in the East of the country);
- Beating of the arrested with the aim of disposing for an acknowledgement of fault and cooperation with prosecution for giving testimony against other figurants of the case ("helicopter case", or the "case of tax collectors");
- Actual suspension of the former President from participation in the criminal case brought against him expressed via denial by the court to provide Victor Yanukovych with a possibility to participate in court via a video-conference conducted within confines of the international legislation.

Apart from discussion of the socially important processes, the participants of the meeting made Professor Schirrmacher aware of the problems with observation of the rights of lawyers. Criminal and disciplinary proceedings, threats from the side of representatives of state authorities, and radical groups, damage of personal property, and attacks are all part of the reality the Ukrainian lawyers face in their work, especially when they participate in the cases which have a "political coloring". The President of ISHR noted that protection of human rights defenders and lawyers is an important direction in activities of the international organizations, in particular, the UN and other organizations on human rights protection (including ISHR).

One of the ways to provide for protection of lawyers and their clients, as well as human rights defenders is a thorough dissemination of information and publicity in their work. Modern means of communications provide for a possibility to disseminate information promptly. However, there exists the risk of persecution of lawyers and human rights defenders from the side of the persons who do not wish to make the materials of criminal cases public, who prefer "quiet" criminal cases that the public is not being made aware of. Search for a balance between the necessity of dissemination of information and a danger by so doing of bringing harm to a lawyer or a human right defender is an important task in building the information work.

Within the framework of the meeting the issues of interaction between the civil society of EU countries and the Ukrainian lawyers and human right defenders were discussed. The variants of cooperation may include:

- Search of international specialists for provision of expert conclusions within the framework of criminal cases;
- Preparation of reports by international human rights organizations and their subsequent use as the evidence for addressing the European court for human rights (ECHR);
- Participation of international human rights organizations in the ECHR cases in the format of a "third party intervention".

Further process of establishing contacts between the civil society of Ukraine and those of EU countries, as well as a dialogue with bodies of State authority are an important step on the way to implementation by Ukraine of the declared course of reforms, including the reform of judicial system.

In the building with us is a hospital, a clinic, and a nursing home, so the hospital beds are very important to us and all medical supplies can be allocated where they are needed most. Since our country (Lithuania) is small and poor, we very rarely

receive necessary

support; items such as bedding, diapers, medicines, and bandages are not given to us by the state, and patients mostly must buy them themselves, so your support is a great relief for poor patients. Thank you again for your effort and your help.

DR Congo: Peacefully protesting Catholic churchgoers killed by security forces

8 deaths in crackdown on protest against President Kabila on Dec. 31

The Catholic Church in the Democratic Republic of Congo has called for peaceful protests against President Joseph Kabila. Kabila's constitutional term was over in December of 2016, but he did not step down. An agreement was made through the Catholic Church that he was allowed to remain in power with the provision that elections would be held in 2017. Because Kabila violated the agreement and no elections were held, the Catholic Church has called for open protest for him to step down.

Kabila banned public demonstrations in September of 2016, and has since violently cracked down on protesters. On December 31, security forces attacked a large peaceful demonstration of Catholic churchgoers after Mass in the capital of Kinshasa, killing an estimated 8 people and wounding nearly 30 others. Kabila also cut internet access in the capital to prevent further demonstrators from gathering.

Dr. Emmanuel Ogbunwezeh, expert on Sub-Saharan Africa in ISHR Germany, stated that Kabila's actions are nothing new in the African context; shutting down opposition through limiting freedom of expression and even violent repression is a common pattern for African dictators who have fallen out of favor. However, it remains a serious violation of human rights which should be condemned by the African and international communities.

Follow-up from the humanitarian aid transport to Iraq

Medical supplies, school supplies, and sewing machines delivered to refugees in Shekhan, Kurdistan

In the last edition of the newsletter, the latest transport of humanitarian aid for refugee camps and communities in northern Iraq (Kurdistan) was being prepared by ISHR Germany. On January 17, it arrived in Dohuk, and in the following days, the goods were distributed in the nearby Sheikan refugee camps.

On February 12, the head of humanitarian aid to Iraq of ISHR Germany, Khalil Al Rasho, received the following message of thanks regarding the delivery of medical supplies from Dr. Fouad Khudida Qasim Alabidaal, a general surgeon working in Shekhan: 'We would like to send you our great thanks for all the members of IGFM for your

great support to us

and we would like to notify you that all the medicines and medical materials have been received and distributed to the patients that need them'.

However, not only medical supplies were delivered, but also supplies for schools located in the camps in Sheikan, as well as for a new sewing studio! ISHR Germany has been progressively developing the sewing course program for refugee women over the past several years, to help provide a source of skill development, occupation, interreligious understanding and interaction, and create a

As of the end of January, the German section of the ISHR also received official recognition as an aid organization by authorities in Iraq, which will continue to simplify the process of delivering humanitarian aid to this area and to those who need it in the future.
